Hereinafter referred to as the "Bully". Further, this "Bully" is guaranteed by Southern Style Bulldogs as follows. The "Bully" is a purebred English Bulldog. This litter is registered with the American Kennel Club as indicated above and an individual registration form will be furnished to the buyer after the breeder has received payment in full along with signed Contract and Health Guarantee. To the best of the Breeders knowledge, at time of sale the "Bully" was in excellent health. Breeder will provide Buyer with a copy of the puppy's medical record detailing medical treatment received under Breeder's care as well as recommended medical care that the Breeder feels is essential to puppy's well being and continued good health. Breeder will be available for the life of this "Bully" to answer any questions and provide help in any way. Further, Buyer must take the "Bully" to a licensed vet within 72 hours after taking possession, for a post purchase general health examination. If, during this health exam the "Bully" is found to have a serious health problem, the Buyer must return the "Bully" along with the Vet's written diagnosis as to the health issue so that Breeder's vet can review and provide a 2nd opinion. As long as the Breeder's vet concurs with Buyer Vet diagnosis, the buyer will receive a credit of paid purchase price of puppy to go towards a different puppy. Return of "Bully" must be within 72 hours of Buyer's vet diagnosis. The finding and opinion of the Breeder's veterinarian are to be considered final and ultimate opinion. Further, Breeder will not provide a refund or exchange for any "Bully" which was injured or became sick after leaving the Breeder's premises. Buyers are advised to limit the exposure of their new puppy to non-household dogs and outside high traffic dog areas until the puppy is at least 12 weeks old and has received its final puppy vaccination. It is in the pups best health interest to not expose them to very many outside dogs and high traffic areas until the last vaccine is given. Further, Breeder represents that the "Bully" has been bred to the breed standard physically and the "Bully" is being sold with a sound, stable temperament. This temperament assertion is based on daily observation of the puppy from birth and Breeder's knowledge of "Bully's" ancestry. Further, Buyer by signing the contract acknowledges that behavior and temperament is based on a combination of genetics and experiences the "Bully" gains, not only with the Breeder but with its new family and in its new environment. Improper socialization and lack of consistent Obedience training will adversely affect the good genetic temperament the "Bully" was born with. Further, this is a non-transferable contract. Buyer agrees to Breeder demand that Buyer MUST notify the Breeder immediately should the Buyer, for any reason, not be able to keep said "Bully" at any point in the "Bully's" life. Breeder will have the option of buying "Bully" back for an appropriate price or allowing Buyer to find a suitable home. UNDER NO CIRCUMSTANCES will Buyer send said "Bully" to a shelter or a breeding facility. If the Buyer violates this term of the contract Buyer will pay a penalty to the Breeder equal to the full purchase price of the "Bully". UNDER NO CIRCUMSTANCES may the Buyer destroy said "Bully" before discussing this decision with the Breeder, except for urgent health reasons (documented by a Vet) which

would impact the "Bully's" quality of life. If the Buyer violates this term of the contract Buyer will pay a penalty to the Breeder equal to the full purchase price of the "Bully". Buyer agrees to remain in contact with the Breeder, to call or e-mail should they have questions or need advice about their "Bully". Buyer agrees to keep the Breeder updated of the "Bully's" health, longevity, titles/awards earned and to send pictures as often as possible. By entering into this contract, you are gaining a relationship with a breeder who truly cares about the welfare of their dogs and who expects to hear from you regarding OUR "Bully". Buyer has read this contract, understand fully the contents thereof. Failure of the Buyer to live up to any part of this agreement will entitle the Seller to reclaim the "Bully" and its AKC Registration paper's which will be transferred back to the Seller. Seller will not be further obligated to the Buyer in any regard. Buyer agrees to all the terms and conditions and agrees that the place of legal venue and jurisdiction is in Ash Flat, Arkansas (Sharp County).
